Now this is a really interesting email string between MBUSA legal (Gail Slaughter) and a Constance Petros of NCFTA, NCFTA stands for National Cyber-Forensics Training Alliance. Ms. Petros took it upon herself to notify her membership (BMW, Toyota, Chrysler, GM, Honda, DHS, ICE, FBI) that I had been charged "with conspiring to manufacture and sell counterfeit diagnostic equipment worth over \$15 million". I wonder if Ms. Petros ever did a follow-up notification informing the NCFTA membership and others:

That MBUSA was 100% aware of what I was doing for years.
(Documented)

That MBUSA was in admitted violation of an EPA Final Rule, unlike her other members. (Documented)

That an MBUSA representative, at my misdemeanor sentencing, actually accused me of putting Mercedes Benz owners at risk without presenting any evidence (there was none!). (Documented)

That the FBI agent-in-charge was removed from the case because he had been caught violating my attorney/client privilege. (Documented)

That the FBI agent-in-charge was found guilty of violating my Miranda Rights. (Documented)

That I was indicted three times on nine felony charges, but the government settled for one misdemeanor count. Talk about a waste of tax payer money! (Documented)

The reader should note that this document was supplied to me by MBUSA during the civil litigation on my case.

The following analysis is regarding the individual **Rainer Wittich**.

An automotive industry partner alerted the NCFTA to **Rainer Wittich**, and **The Brinson Company**. As part of NCFTA's ongoing efforts relative to the Brand & Consumer Protection Program, an assessment of Rainer Wittich was completed. The target individual was *charged with conspiring to manufacture and sell counterfeit diagnostic equipment worth over \$15 million.* (http://www.justice.gov/usa0/lae/news/2014/2014_02_13_Rainer_Wittich_Brinson_Company_ind.html) Analysis revealed multiple companies and a domain associated with the individual.

Public records identified that Rainer Wittich is connected to the following addresses:
