My name is Rainer Wittich. You can find me easily enough on the justice.gov website. What the FBI and U S Attorney's office left out was the following :

Lead FBI agent Sundonah Parsons knew that the ex-employee / whistleblower was lying prior to the raid and prior to my indictments . Apparently lying to the FBI is not that big of a deal if you're a whistleblower.

Lead FBI agent Parsons, with the help of co-agent Robert Smythe fabricated my 302. Agent Tracie Smith found out about this a short time after the raid.

Agent Parsons lied under oath at my Miranda hearing, which I won by the way.

It also turns out that Agent Parsons threw Agent Smythe under the bus during his testimony by blaming the fabricated 302 on him. Class act !!

Agent Parsons intentionally violated my attorney / client privilege in Dec of 2014, approximately 8 weeks prior to a Feb 2015 scheduled trial date.

And yes, I did plead guilty to a misdemeanor, not because I believed I was guilty, but because I ran out of money.

Dear Mr. Wittich:

This is in response to your correspondence to the Office of Professional Responsibility (OPR). In your correspondence, you alleged misconduct by an Assistant United States Attorney for the Eastern District of Louisiana and two Federal Bureau of Investigation agents in connection with your case.

OPR has jurisdiction to investigate allegations of misconduct involving Department of Justice (DOJ) attorneys that relate to the exercise of their authority to investigate, litigate or provide legal advice, as well as allegations of misconduct by law enforcement personnel when they are related to allegations of attorney misconduct within the jurisdiction of OPR. It is, however, the policy of this Office to refrain from investigating issues or allegations that could have been or still may be addressed in the course of litigation, unless a court has made a specific finding of misconduct by a DOJ attorney or law enforcement agent. Based on our review of your correspondence, we have determined that your allegations fall into this category. Accordingly, we concluded that no action by this Office is warranted. You may wish to consult private counsel or contact the nearest Legal Aid Society to determine what additional legal avenues, if any, may be available to you.

We regret that we are unable to be of further assistance to you in this matter.
